We celebrate National Marriage Week February 7-14. I'd encourage you all to spend time in Eucharistic adoration praying for all those dating, engaged or married.



## JANUARY GENERAL GATHERING RECAP

The January ODCCW General Meeting took place on Tuesday, January 20, 2026 at St. Elizabeth Ann Seton Parish in Irvine at 10 am. Carol Palmer, ODCCW President-Elect, opened with introductions and Opening Prayer, Salute to the Cross, and Salute to the Flag. Pat Martin, ODCCW 1<sup>st</sup> Vice President of Spirituality, led us with a prayer. Carol Palmer introduced and announced Nancy Castenholz as 2<sup>nd</sup> Vice President of Service. Nancy spoke of the Box of Joy project being very successful with 72 boxes having been sent around the world to underprivileged children this past Christmas.

Kay Ehret spoke about attending our sponsored seminarian Francis Ang's ordination for deacon on December 6 and presented him afterwards with a check for \$400 collected from our ODCCW General Meetings. Kay also spoke of The Shroud Experience exhibit at the Christ Cathedral. She invited those interested in attending to make reservations. The ODCCW Executive Board will be attending the exhibit on March 3 if others wish to also attend with us on that day. Carol Palmer did mention that there is another seminarian who is in need of a car should anyone wish to donate theirs to him.

Carol Palmer then introduced our guest speaker, Fr. Chris Heath. His talk was titled "What's a Nice Priest Like Me Doing in a Place Like Archives?" Fr. Chris has a most impressive resume: He was ordained on October 1, 1988 and was a Law Enforcement Chaplain for 20 years; Chaplain at Hoag Hospital in 2007; Knights of the Holy Sepulcher in 2011; Chaplain of pilgrimages in 2013; Spiritual Advisor of ODCCW since 2023; and Director of Mission Office since October 1, 2025.

On July 7, 2021, Fr. Chris became the Archivist of the Diocese of Orange after being previously assigned at St. Hedwig parish. He gave a most informative talk about how he became the Archivist following Fr. Bill Krekelberg's retirement in 2015 as 1<sup>st</sup> Archivist. During this time, the role of Archivist went unfilled from 2015 – 2021. Bishop Vann recognized the evident need for an Archivist. Fr. Chris was the logical choice to fill that role as Bishop Vann wanted a priest with a living memory of the beginning of the Orange Diocese. Additionally, Fr. Chris was the youngest of the priests to choose from; thus, began his succeeding role as Archivist. Another interesting note is Fr. Chris' mother was a photographer for diocese activities and many of her photos are now part of the archives.

A 50/50 raffle drawing then followed the presentation, with several winners. Lunch was served afterward, and the Closing Prayer was read.

On Tuesday, February 17, 2026, the Annual Retreat will take place at The Heart of Jesus Retreat Center. It will begin at 9 am and will conclude after 3 pm (includes Mass starting at 2 pm). The fee is \$50 which includes continental breakfast and lunch.

## Six States Pressing for Action on Mail-Order Abortion Drugs

Six states suing to stop the flood of these dangerous, deregulated drugs. **Florida and Texas:** Florida Attorney General James Uthmeier and Texas Attorney General Ken Paxton **sued** the FDA this month over its illegal actions in approving and progressively eliminating safety standards on abortion drugs. **Think your kid's done with a booster seat? New California law says maybe not**

Most States have laws that require children under eight years old or under 4'9" to use booster seats. California is one such State. But thanks to a new law signed by the Governor [Newsom] back in October, children as old as 16 might soon need to use booster seats if they can't satisfy the law's new criteria. Starting in 2026 and going into 2027, California's booster seat law (**AB 435**) shifts from age/height to a 5-Step Fit Test for kids 8-16, meaning if they don't fit an adult seatbelt properly (knees bent, belt across chest/hip, sits back), they still need a booster, with fines up to \$490 for non-compliance, keeping shorter kids safer in boosters longer.



**Senate Bill 1053**

California's plastic bag ban in 2026. It outlaws single-use plastic bags and the thicker ones. Stores are required to offer recycled paper bags to reduce pollution. Bag cost is 10-cents.

**Senate Bill 640**

California State Universities will no longer need students to apply. Good grades will automatically admit them.

**Assembly Bill 1830**

Believe it ... this law will require corn masa flour and wet corn mas products to add 0.7 milligrams of folic acid to their masa products.

**Senate Bill 43**

After 50 years of mental health practice, this law will change the mental health system to be able to detain people, possibly against their will, who maybe: 1) danger to self, 2) danger to others, or have a grave disability.

## Jerusalem, My Destiny

*Lent: February 18 to April 2 and Easter April 5.  
Passover: Wednesday, April 1<sup>st</sup> and ends Wednesday, April 8.*

Jerusalem was our destiny in 2017. As we walked the "Way of the Cross", Ralph was asked to hold the "Cross" at the eighth station. For many Christians and Catholics, Jerusalem is their Destiny. Some people go on their own, others join a tour. Their goal, like us, is to walk the "Way of the Cross" and to see the site of the Jesus' crucifixion.



During this Lenten season, you might consider a virtual pilgrimage to Jerusalem. These are available in many formats. Some tours are interactive while others are meditative.

As we take a fresh look at lent, let us ponder on how Jerusalem become a pilgrimage site. Actually, it began in Nazareth, a small Jewish community where a little Jewish boy named Jesus was raised, grew up and as a 30-year-old man began His ministry. He was known as the Messiah and was crucified and died at 33.

It is interesting to read the Bible through the old and new testaments and see how Passover and Easter coincide with each other.

Jews celebrated the Passover Holiday on the first anniversary of their freedom from Egypt. They celebrated Exodus, as commanded by God, to eat the Passover lamb on the night prior to the Exodus (Exodus 12:8), commonly known as the "seder meal".



Early followers of Jesus were known as "The Way" before the term "Christian" was widely used. The term "Catholic Church" was first used by St. Ignatius of Antioch around 107 A.D. and the term "Catholic" means "universal," reflecting the Church's mission to spread Christianity globally.

As Christianity spread, new traditions evolved, one of them, the 40 days of Lent. The Bible uses the number 40 to represent a period of trial or testing. For example, the 40 years that the Israelites wandered in the wilderness, and the 40 days that Jesus fasted in the desert.

As we approach the holiest time in the Church to solemnly celebrate Ash Wednesday on February 18, let us purify our hearts and minds today. It's time to pause and reflect on what we can do during this sacrificial time of praying, fasting, and almsgiving.



Consider doing a Pilgrimage. It isn't as hard as you think. Although the traditional Pilgrimages are visiting the Holy Land, Lourdes, and Fatima, but did you know that visiting any spiritually significant site, like praying in front of the tabernacle, visiting a church other than your parish, and placing flowers on a gravesite is also considered a pilgrimage?

If Jerusalem is your destiny, your Lenten journey begins now, "Let no one walk alone, the journey makes us one" (from the hymn, Jerusalem, My Destiny).

**DRESS UP: Improve Your Attitude**

Growing up in the 50s and 60s, we always looked nice for Mass because Mom said, "You're dressing up to visit our Lord's house." Mom believed and taught me that dressing appropriately lifts your mental attitude and self-image. She said, "What you wear makes you either approachable or avoidable."



Recently, after Sunday morning Mass, I was approached by a woman who said, "You remind me of Queen Elizabeth with your beautiful outfit." I was flattered by the comparison. Several times women have approached me and said, "You look lovely. I wish more people dressed for Mass."

At Mass, I see women and children wearing clothes that's too revealing. Many priests avoid this subject because it appears to be too controversial. One young priest addressed this issue of modesty by telling us that as a child, every Sunday, he wore the same outfit to attend Mass, black pants, white shirt, and black shoes. He made the point, "Dress appropriately for Mass, wear your shorts when you get home." It's time we step up and tell our kids and grandkids to dress respectfully to honor and respect our Lord.

St. Paul wrote in Romans 12:1-2, "I appeal to you...by the mercies of God, to present your bodies as a living sacrifice, holy and acceptable to God, which is your spiritual worship. Do not be conformed to this world, but be transformed by the renewal of your mind...", also in Psalm 29 ... Give to the LORD the glory due his name; adore the LORD in holy attire (Psalm 29...).



My husband joined me one morning to shop at Walmart. While I was busy looking for fresh lettuce, he said, "Can you believe that!" I said, "What?" "Over there, that woman in pajamas." I hadn't noticed because it was so common. But after he noticed, it made me realize that pajamas don't belong in public places!


There's a time for pajama days when you are sick or bedridden.
